Inf. 8 Capacity Development

- Informs about the status of WMO's competency frameworks and the knowledge and skill frameworks with links to INFCOM (as published in WMO No-1209), as well as the need to review, update if necessary or develop new frameworks;

- To endorse the plan for capacity development based on INFCOM's work plan;
- To bring to the forefront mechanisms supporting capacity development initiatives.

Capacity Development

- Outcomes of Decision 8/1:
 - Increase awareness and access to CD-related material led by INFCOM
 - Increase reference to Global Campus when relevant
 - Identify outreach mechanisms, communication of training activities
 - Identify process for enhanced sharing and coordination within INFCOM and also between regional centers and RTCs
 - Identify means for efficient translation of material
 - Competency Frameworks: Identify needs and plan – process to be discussed with CDP
 - Increase awareness of ETR expertise
