



# WMO Global Campus Collection of Learning Resources

## Submission Guidelines


All education and training providers are invited to submit information and links about their learning resources. Your contributions will greatly benefit the WMO community. The amount of required information kept brief to keep the work to make a submission to a minimum, but be sure to enter complete and accurate data, including copyrights. This will help users find those resources more relevant to their needs.

 This symbol indicates required information.


 **Title** : Use the standard title of your resource or enhance it with additional words to help with keyword searches by users.


 **Description** : Use a clear and complete content description, but also include statements about the type of learning resource. How is the resource used? Using terms for the resource type such as those provided below will help with the consistency of the collection. Please use your own terminology as well. *Learning resource type*: self-directed learning, group activity, lecture, reading, simulation, case study, activity requiring review and feedback

Describe audience and all those that will benefit from the resource, especially if a WMO Competency Framework is not identified.

 **Format** : Choose from the list. Choose “Other” if necessary and describe the format in the Description.

 **Web link** : Enter a valid URL (be sure to test)

 **Author of resource** : Institution or individual that created the resource


 **Contact** : How a user or collection manager can ask questions about the resource


**WMO Competency Framework (check all that apply)** This field is not required only because competency frameworks do not exist for all topics. But it is critically important for user searches to know which competencies can be supported by the resource. If a competency framework is applicable, please use it. Often, more than one framework is relevant. If NO competency framework is relevant, be sure to describe the audience for the resource in the Description.
