EC-CDP Engagement with WMO Gender Equality Action

1.Gender Website and Terminology

- The updated WMO Gender Website will feature a dedicated "Spotlight" section to highlight women in hydrometeorology, including WMO experts, gender focal points, and youth.
- The "Spotlight" will initially focus on the stories of WMO Gender Focal Points, and other experts.
- Efforts will ensure that youth remain a primary target audience, with Spotlight stories showcasing young people from various countries (e.g., university students).
- A template will be developed to standardize the Spotlight stories.
- A common gender language and terminology that is adaptable across all countries will be developed.

2.Community of Practice (CoP)

• The CoP will provide a platform for WMO Members, Constituent Bodies, and expert groups to share best practices on gender collectively. The CoP will have a clear "Calendar of Conversations," initially focusing on three key themes:

Mentorship: Identifying existing programs and promoting new ones.

Women's Representation: Focusing on women's inclusion in training, capacity development and spotlight on women in science.

Gender Awareness: Aligning terminology across all WMO bodies.

- EC-CDP will contribute to the CoP as knowledge connectors. The Panel may also present recommendations to the EC and the EC-Gender Focal Point.
- The EC-Gender Focal Point will be the CoP Leader, and the experts from EC-CDP and ETR will contribute to the CoP as Champions.
- CALMet and CONECT will be invited to support CoP efforts.
- A monthly digest will be developed to collect and share best practices and upcoming events from the CoP.

3. Joint CALMET-CONECT Conference

• A session about **Women's Inclusion in Training** is in the Agenda of CONECT-3 Plenary meeting and will be coordinated by secretariat in collaboration with ET-EPC.

4. Engagement with EC-Gender Focal Point

• Inputs and ideas will be presented to EC-Gender Focal Point to foster engagement with EC-CDP expert group
